

## Projected Revenue by Fund Source




This chart shows the total general purpose revenue Hart-Ransom Academic Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Hart-Ransom Academic Charter School is \$4,683,595, of which \$4553795 is Local Control Funding Formula (LCFF), \$114800 is other state funds, \$15000 is local funds, and \$0 is federal funds. Of the \$4553795 in LCFF Funds, \$251105 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Most of the expenditures that are not included in the LCAP are for salary and benefits for staff, including worker's compensation. Instructional supplies, office supplies, library supplies, utilities, school services, repairs, advertising, audit expenditures, and site improvements are also not included in the LCAP.

## Increased or Improved Services for High Needs Students in the LCAP for the 2022-23 School Year


In 2022-23, Hart-Ransom Academic Charter School is projecting it will receive \$251105 based on the enrollment of foster youth, English learner, and low-income students. Hart-Ransom Academic Charter School must describe how it intends to increase or improve services for high needs students in the LCAP. Hart-Ransom Academic Charter School plans to spend \$564000 towards meeting this requirement, as described in the LCAP.

Our expenditures for high-needs students include online resources such as Florida Virtual Schools services and "voucher" services for families to use toward our offsite vendors. These two expenditures make up the majority of the expenditures. Other expenditures include curriculum, consumables, math kits, computer software, STEM (Science-Technology-Engineering-Math), and STREAM (Science-Technology-Robotics-Engineering-Arts-Math) materials, and field trips. We are increasing our funding for high-needs students through our Barton tutoring and math tutoring services. Our parents, staff, and students have all asked for more tutoring and support. In addition,

we were able to hire and retain a math teacher who teaches our middle and high school students.

Our educational partners have heard about our funding and materials purchased by the advisory teachers, newsletters, and other publications. We have held virtual meetings, used surveys, and sent emails to gather input from our educational partners. On April 26, 2021, we invited our educational partners to provide input for the use of AB 86 funding (Expanded Learning Opportunity Grant). All staff and parents agreed to use the funding for a future building that could expand our onsite enrichments, provide space for the high school and middle school students to

have more lab space, and more room for parent training.

Our school did not receive additional money because we do not meet the criteria for the funding.

Our school did not receive any one-time federal funding. We did use some funds expanded learning (AB 86).

Our school has continued to serve our students and families during the 2021-22 school year with the plans that were developed last year. However, we have eliminated some of the plans or edited some of the plans based upon staff and parent input. We serve home educators with advisory teachers and other support staff. We did not dramatically alter our plans for guidance and support of our families. We continue to follow COVID-19 protocols, and we also had in-person enrichment courses as well as regularly scheduled meetings with families for training or accountability purposes.

## Plan Summary [2022-23]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Hart-Ransom Academic Charter School is a pivotal partner for families choosing homeschool and distance learning options for their children. The high school program has multiple pathways for students, including a dynamic early college pathway where students earn college credit while enrolled in high school. Hart-Ransom Academic Charter School is fully accredited by the Western Association of Schools and Colleges (WASC) for grades TK-12 and has a robust instructional program based on the philosophy that all students can learn and achieve success. Hart-Ransom Academic Charter School was established in 1995 as a dependent charter school in the Hart-Ransom Union School District.

The program promotes learning through 21st-century skills of communication, collaboration, creativity, and critical thinking, assisting students to meet and exceed grade-level standards. Hart-Ransom Academic Charter School has aligned its Local Control Accountability Plan (LCAP) to provide for the needs of our students. The staff, parents, and students at HRACS continue to be the heart of the school. Students can have differentiated courses and textbooks supported by advisory teachers who provide guidance to the parents as they educate their children. Additional school support includes the school principal, a resource specialist, an academic advisor, as well as district-wide services such as a speech therapist, psychologist, and school nurse.

Parent input is paramount at our school! Our parents are their children's teachers, and we advise, support, and train them to do their very best.

## Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Our ELA scores have been steadily increasing over the last few years as we have moved from yellow to blue. Our math scores saw a significant increase in 2019, and the scores are now in the yellow range. We saw a decrease in our overall ELA score and an increase in our math score for the 2020-21 school year. Our continued focus on the development of higher-order thinking skills is working. Our math scores have been improving, and we are waiting for the 2021-22 scores. Even though our ELA scores saw a decline, we are witnessing an improvement in our writing and comprehension scores.

## Reflections: Identified Need

Our math scores have indicated a need for higher-order thinking skills, application of math skills, and improvement with communicating reasoning. Socioeconomically disadvantaged students continue to need some added support, and we have added additional math support. We hired a math teacher who can support on-site instruction, and we are adding more classes to support our need to improve math instruction. We implement state board adopted academic content and performance standards for all students, but our parent-educators need more training and support. Our school will be training our staff and parents to meet the needs of all students, but we need more targeted training and support for our EL and low-income families. Our intention for the new school year is to have more training and support for staff, parents, and students.

## LCAP Highlights

The ongoing strategic plan for Hart-Ransom Academic Charter School is to support students and families with the option to educate students at home. The LCAP includes maintaining tools to equip, monitor, and enrich the independent, personalized learning environment school-wide. Our new math and science advisory teachers have guided us with improving reasoning skills as well as coaching staff and parents to better serve their students. Our overarching goal is to improve the progress with ELA while we continue to focus on improving math instruction at home. We have expanded our on-site enrichment activities for our students, and we are adding some new offsite vendors as well. For the 2022-23 school year, we are adding an additional math class and more technology courses.

# Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Hart-Ransom Academic Charter School conducts several surveys to our families, students, and staff to gather input. We also conducted virtual meetings with parents and staff to gather ideas for the support of parents and students. We surveyed our families at the end of December 2021, at the end of February 2022, and at the beginning of March 2022. Parents were able to add information through April 2022 on a Google document. The two bargaining members on our staff were asked for input and both provided input and suggestions. Our advisory teachers also were surveyed, and they provided input and guidance. All staff then met to discuss the direction of the surveys.

A summary of the feedback provided by specific educational partners.

Our students completed a survey with these topics: "I enjoy homeschooling because..."; "Describe any areas of improvement"; "List areas of support that you would like to see added"; and, "List any programs, activities, or enrichments that we should continue". Many of the students and parents said they enjoyed the flexibility of homeschooling, or they stated that they appreciated the ability to spend more time with family, more time with the subject matter, etc. Our high school parents and students are thankful for dual enrollment classes at the local junior college. Parents and students mentioned their love of the enrichment program that allows students to take a variety of courses such as martial arts, art, music, writing, coding, drones, rock climbing, etc. Parents and students mentioned that they liked the new books in the library, but they also asked for support in math, more local field trips, and more activities that focus on our high school students. Parents and students continue to ask for tutoring, especially in math. Parents and students continue to ask for vocational training, more coding classes, more field trips, more counseling/advisory time, more science labs, and more opportunities to socialize on campus or at a local park. Most of the comments focused on enrichment courses, extra tutoring in math, and field trips.

Parents and staff comments were similar to student responses: maintain or increase field trips, more social activities for students, more math support, and more parental training support. Parents also mentioned our parent group as a way to support each other and build relationships.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

The current plan was influenced by student, parent, and staff input. Specifically, we will hire additional staff to tutor on-site math, and we will offer training and support classes to parents, especially with mathematics. We are exploring more activities for students such as athletics, as well as increasing the amount of math support for our struggling students. Our parent group has agreed that we need more activities to improve relationships and build a network of support.

Our overall math scores have been persistently low and below county and state averages. Parents, students, and teachers have asked for more support. Our long-term goal is to increase overall math scores so that at least 50% of the students will meet or exceed standard by June 2024. Our overall ELA goal is to increase scores so that at least 70% of the students will meet or exceed standard by June 2024. Our staff and parents continue to ask for reading and writing classes and support. Improve reading, writing, and research skills so that students will be able to engage in research and inquiry to investigate topics, and to analyze, integrate, and present information.

## Goal Analysis [2021-22]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

2021-22: Our goal was to increase student achievement for all students. We saw a decrease in our ELA scores, but an increase in our math scores. One substantive difference between planned actions and actual implementation is the area of workshops (1.2, 1.9). Our school staff and parents were still mindful of COVID-19 restrictions and guidelines, so these workshops (1.2, 1.9) did not occur. Teacher training fell short of goals, but we are recalibrating our efforts for next year (1.4). We did not see a significant need to purchase diagnostic assessment software or materials, but we are discussing the need for 2022-23 with a possible pilot for new assessment tools or supports (1.7).

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

2021-22: Our math instructor (1.1) did not have as many units or years of experience, so we will have a carryover for the 2022-23 school year. Our math and language arts workshops (1.2, 1.9) did not occur, so we will carryover those funds for 2022-23.

An explanation of how effective the specific actions were in making progress toward the goal.

2021-22: Hiring a math teacher has instantly helped us to increase math scores (1.1). Math kits and other support materials were purchased for parent-educators (1.3), and the parents are able to integrate more concrete use of materials into their math lessons. Our new Barton reading tutor has provided us with much needed support for our struggling students (1.5).

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

2021-22: We must continue to disaggregate the data to understand that the CAASPP test itself was revised to decrease the number of tested items, thus skewing results. However, our local assessment use has increased, and we will continue to research and investigate the purchase and use of a new local assessment tool. In the meantime, we will continue to use STAR math and reading. We saw a decrease in ELA scores (CAASPP), but we had positive growth in math scores. We were able to hire a new math teacher this year (1.1), but we overbudgeted. Therefore we have reduced the amount of action item 1.1 slightly to reflect budget needs. Although we did include math workshops this year (1.2), we did not spend the amount budgeted. Therefore, we have reduced the amount from \$10,000 to \$1000 for action 1.2. Action item 1.6 was increased to allow for the purchase of new technology. We will be replacing our drone fleet, and increasing robotics and other technology for our STREAM (Science-Technology-Robotics-Engineering-Arts-Math) classes. Action item 1.7 was reduced to reflect the need for professional development and not to purchase more diagnostic assessment tools. We will continue to use STAR assessments, but we need some professional development to better understand the assessments. Action item 1.8 was increased to accommodate an increase in enrollment. Our student body has grown, and we have new math classes that need materials, software, or subscriptions. Action item 1.9 is eliminated for the 2022-23 school year because we do not need the money for training. Our teachers are providing the training, so we can eliminate extra funding. Action 1.10 was increased to accommodate an increase in enrollment in the high school. Our high school

enrollment has increased by twenty students, so we need additional FLVS classes for those students. Actions 1.1 - 1.10 were modified to reflect the direction of the contribution of funding to improve and increase services for our students.

Our goal here is to increase school and community engagement while maintaining a safe, positive culture, and learning environment. We sought to increase the number and variety of vendors for family activities and family interaction, and that happened this year (2.1). We are

currently evaluating current vendors for 2022-23, and we are accepting new vendors that can offer an array of courses our activities for our students (2.1).

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Our action item 2.1 met the needs of our families and students, but the program will need to be audited more closely during the 2022-23 school year. Sadly, we were not able to hold any student government classes (2.2) in 2021-22, but we are planning to have meetings with our students to include student government for the 2022-23 school year.

An explanation of how effective the specific actions were in making progress toward the goal.

Because our school is a home-based school where parents are the educators and our advisory teachers provide support, we have constant communication between parents and teachers. In addition, we provide frequent opportunities for parents to complete surveys, provide feedback, and address concerns. We are able to work with all of our families, and we have started to use additional forms of communication including virtual and multi-stream tools such as Parent Square.

Many strengths were identified: on-site support classes, field trips, and parent training and support. Challenges include a call for vocational training, more coding, more field trips, more counseling/advisory time, science labs, and opportunities to socialize on campus. Most of the comments focused on enrichment courses and field trips.

Parents and staff suggested that we need to improve our on-site classes for math with extra support for parents and students who do not understand the standards or the specific skill. Parents also mentioned a parent forum or discussion group to support each other and network skills.

Many new field trips have been planned with a specific interest in bringing families together to network, plan, exchange ideas, etc. We have already seen more families involved in field trips and activities.

We were not able to implement student government yet (2.2), but we have included a student leadership enrichment course that we will continue to improve. Our parent involvement in field trips increased (2.1), and we will continue to monitor and improve our field trip offerings for our families. Action 2.1 was modified to reflect the direction of the contribution of funding to improve and increase services for our students.

- to learn best practices to support our families of English learners

In addition, we will use diagnostic assessments to better understand individual students' skill levels. These training opportunities will be offered to parents and teachers throughout the year.

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### Contributing Actions Annual Update Table

- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

**LCFF Carryover Table**

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9).
